## **Construction Progress**

Preparatory works have commenced on site ready for demolition to commence later next month. Activities undertaken last month include:

- Installation of scaffolding up to gantry level
- We are currently in the process of completing the installation of hoarding along St Vincent's Street.
  This will be completed by 14th September

## **Forthcoming Works**

 We expect to commence demolition works at start of October. These works are expected to take approximately 10 weeks to complete

The control of noise and vibration will be of significant importance throughout this project, with specific controls measures put in place to ensure the least possible impact on the school and our surrounding neighbours. Construction plant and methods will be chosen to ensure the least possible impact. We will regularly monitor construction noise and vibration.

## **Dust Control**

Numerous dust mitigation and preventative measures will be employed to prevent the migration of dust.

#### Deliveries

Deliveries are scheduled around local school drop off and pick up times. Site deliveries are restricted to outside the hours of 8.30 - 9.30 am and 3 - 4.30pm.

## **CLOCS**

CLOCS (Construction Logistics and Community aims to bring the construction logistics industry together to revolutionise the management of work related road risk (WRRR) across the industry in order to ensure vulnerable road user safety. Neilcott are CLOCS champions, actively implementing the requirements within the standard.

Neilcott communicates the CLOCS requirements to our supply chain and encourages them to become members of the Fleet Operator Recognition scheme. The scheme encompasses all aspects of safety, fuel efficiency, vehicle omissions and improved operations.
